GENERAL RULES APPLY TO ALL CLASSES

1. All entrants under 16 must have a parental permit signed, and on file at time of race and a parent must ride with them
2. All entrants must wear an approved helmet, eye coverings, and seat belt at all times while participating.
3. No drugs are allowed on the Cumberland Co. fairgrounds at any time, and anyone under the influence of drugs will not be permitted to participate or be admitted on grounds. Under No circumstances, will any Disagreements with the Officials, other participants, or anyone, be tolerated, or you will have to discuss the matter with the Sheriff's Department.
4. ***** Judge's decision is FINAL.** All cars and trucks will be inspected the same. Any infractions, of any rule, will deem that car or truck illegal, and given the opportunity to correct the problem. If this cannot be done, it will not be allowed to compete! Car or truck may be inspected at any time, before, during, and after competition. If the vehicle is found to be Illegal, it and the driver, will be disqualified. The Judge's decision is final.
5. Front doors must be painted in a contrasting color to body color for safety. All Glass, Trim, Handles, Taillights, and Molding must be removed and vehicles swept clean before entering the Grounds.
6. One (1) battery only per vehicle. It must be secured tightly and covered. If battery wiggles it's not legal. It must also be located in front passenger floorboard next to tranny tunnel. Battery must be completely covered and/or boxed-in. All holes in firewall must be covered.
7. All stock gas tanks must be removed, and a metal tank used (No Plastic Fuel Tanks Allowed), placed behind the driver's seat, securely fastened to the floorboard, and covered. An electric fuel pump may be used but **must have a kill switch accessible to drivers and officials in case of problems.** No plastic fuel lines, and all fittings must be tight. No leaks. For your Safety! **All electric fuel, pump gas lines should be ran inside another hose or pipe bigger than it and should exit out the bottom of the car in case of a fuel leak.** That will keep it from spraying all over the car, driver or passenger. Garden hose will work.
8. All Radiators must stay in factory position and be filled with Water. No antifreeze or oil allowed in radiators.
9. Front driveshaft must be removed on 4 x 4.
10. 4 OR LESS cars or trucks in a class will run for 1st place money only. Judge's decision on running of class; payout and cancellation of class!
11. No Profanities may be placed on any part of the car where it may be visible when car bends.
12. **All cars must have working brakes, at all times,** if not, instant disqualification.
13. Judges may disqualify any entry at my time if the judge feels the said entry is in violation of the rule, or acting in a dangerous or unsportsmanlike manner. All decisions are final. Arguments, Whining, Sandbagging. Team driving, Hit and Hold tactics, or improper displays during or after the event will get you removed from the grounds and possibly barred from any further Competitions held by us, or The Fair. We will not tolerate any disruptive behaviors.
14. A protest Fee of \$200 Cash must be submitted any time prior to the heat or Feature event. No protests allowed after feature is started or after the show is final. If you feel someone is bending tile rules, Put Up, or Shut Up.
15. We reserve the right to make changes to printed rules at any time prior to the event, so check back near event date for updated rules. **\$40 entry fee** covers driver's pit pass and entry. Passenger entry fee is **\$30.** Other pit passes will be available. No Refund of entry if scratched! No one under age of 16 is allowed in pits. Additional pit passes **\$20.** ***
16. Entry fees may be paid by Cash or by Money order. **Absolutely No Wal-Mart MoneyGram's.**
17. All tires must have air **except pro mod.**
18. **No exceptions to these rules ...If it's in the rules, DO IT. If not, DON'T.**
19. **Judge's decision on day of inspection may override rules - types of welds compared to other - strength of frames.**
20. **Any cars left 24 hours will become property of the Cumberland County Fair Association!**
21. **As a participate you assume all liability in the event of injury, theft.**
22. **Should your actions require law enforcement involvement you will be removed from the grounds and ban from all events for a period of 1 year, or board decides otherwise.**
